1) ABOUT THIS TENDER PROCESS

Based in Constance, Germany, SoH is dedicated to helping those in distress and exploited people worldwide. In Northern Kenya, South Sudan and Ethiopia, SoH implements a project funded by the German Federal Foreign Office (GFFO) to support severely food insecure communities through improved access to MPCA, WASH, protection services, food support and capacity building in partnership with Caritas Marsabit, Merti Integrated Development Program (MID-P), Catholic Diocese of Rumbek, Score and ECC-SDCO Soddo.

A) Scope of work/services:

Provision of accommodation, conference and hotel services as detailed in Annex 2.

B) Eligibility criteria

Interested service providers must meet the following eligibility criteria to participate in this tender;

- 1. Hoteliers must have an establishment within Nairobi/Nairobi Metropolitan (Nairobi, Machakos, Kajiado and Naivasha) regions.
- 2. Legal registration proving that the bidder is authorised to offer hospitality services and carry out business under the Kenyan law
- 3. The bidder agrees to comply with SoH Policies as detailed in Annex 1
- 4. The bidder is not listed on any sanction lists or supplier blacklists





Mandatory Requirements

1. Proof of hotel facilities physical address within Nairobi/Nairobi Metropolitan (Nairobi, Machakos, Kajiado and Naivasha) regions.

2. Copy of valid Certificate of Incorporation/Registration

3. Current Tax Compliance Certificate issued by the Kenya Revenue Authority

4. Valid single business permit/ trading license

5. Copy of brochure detailing all the features and facilities of the Hotel (Accommodation, Conferences and Hotel facilities)

6. Copy of Valid Health licenses for the Hotel–Medical certificate & Food hygiene certificate

7. Attachment of Classification Certificate from Tourism Regulatory Authority (Indicate if Classified or not classified) and any star ratings accredited by relevant body or other similar accreditations/awards.

8. Relevant experience, demonstrating a proven track record in hosting pan African conferences and excellent hotelier services

9. Capacity to provide the specified services for the number of Pax and services as per Annex 2 demonstrated by previous contracts or orders.

10. Self-declaration that the bidder has not been debarred from participating in Public Procurement in Kenya due to contravention of any part of Section 41 of The Public Procurement and Asset Disposal Act No 33 of 2015.

D) Application process

This is an open tender procedure. Bids received after deadline will not be considered. If offers are incomplete, bidders may be able to hand in missing documents within a deadline upon request by the Procurement Officer via <u>tenders@sign-of-hope.org</u>. Sign of Hope reserves the right to extend the deadline for submission, if necessary.

E) Required documents

- Provide all documents needed to fulfil requirements under B
- Technical proposal (as per Terms of Reference above).
- Financial proposal, incl. payment terms in KES.
- Documents confirming the right to provide the required services (e.g. company registration, certificates, licenses, etc.).
- Signed supplier declaration form as per Annex 1 and signed self-declaration.
- At least three references for hosting conferences of similar size(not older than 3 years)
- Previous contracts and orders fulfilled of similar scale

Additional information:

- 1. The financial proposal/quotation shall contain all the prices for the individual services and items as well as the total price (with VAT being stated separately).
- 2. All prices shall be quoted in KES.
- 3. All of the side expenses (taxes, deliveries etc.) should be included into ultimate bid price. Any expenses exceeding bid price shall not be covered.

G) Award

The winner of the tender process will be selected within 7 working days from the deadline-with the possibility of extending this period if necessary to clarify the information contained in the proposals in writing.

Tender results will be communicated to all participants no later than 5 business days from the date of the decision on the winner by sending an email to the bidders. The winner of the tender will be sent a corresponding email within a day from the moment when such a winner is selected.

In the event of a possible extension of the tender deadline by Sign of Hope, the binding period shall be extended, even if its expiry is determined according to a specific date or time, by the period by which the tender deadline is extended, unless otherwise agreed.
